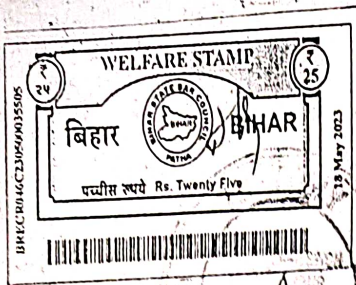

Affidavit

1. That Bihar Technical Education Trust Is registered under Societies Registration Act XXI of 1860 having registration no. 19/1980.
2. That the Bihar Technical Education Trust is a Non-proprietary character.
3. That the school is being run as community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
4. The no part of income from institution is being and will be diverted to any individual in the Trust/Society/Company/School Management Committee or to any other person/entity. The saving, if any, after meeting the recurring and non-recurring expenditure and contributions to, developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the causes of education in the same school only.
5. The school is not paying any charges towards using name, motto, logo or any other non-academic activities to any institution, organization or body.
6. The school will not open classes under CBSE pattern particularly classes IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and Correspondent/Manager of the school have individually gone through the provision contained in the affiliation & examination byelaws and the circulars issued by the board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws directions issued from time to time and the law of the land.
8. That the school will ensure of all statutory requirements like EPF, ESI and labour laws etc with respect to the school and staff of the school.
9. That the school will ensure that the building safety, Fire, Water safety health and hygiene certificates are being issued or renewed by the concerned municipal or state authorizes from time to time as per the prescribed term.
10. That the school will ensure that all required infrastructure is available with the school before starting classes.
11. That the school will ensure that sufficient number of qualified teachers as per the provisions contained is affiliation bye-laws are available with the school before starting classes.
12. That the school will follow the provisions related to fee contained in affiliation bye-laws and will disclose the details of the fee to the students/parents every year before start of session without resorting to any hidden charges in the heads of the fee.
13. That the school will not coerce any student/parent to buy books/stationary/uniform from any particular shop.

16. That the school will not start CBSE pattern classes without submitting a commencement certificate to the effect that the school has complied with all the conditions imposed by the CBSE and the post affiliation conditions contained in affiliation bye-laws along with general rules.
